I refer to the above and our previous letter of 1 July 2021.

As outlined in our previous letter, the Joint Special Administrators (“JSAs”) have continued to hold detailed discussions with a third party who have expressed an interest in acquiring certain of Dolfin’s assets with a view to finalising the terms of a transfer of those assets.

We are now writing to confirm that the JSAs have completed the sale in respect of certain (but not the whole) of those assets.

The third party did not agree to acquire your account and therefore your client agreement was not included in the sale. As a result, you remain a client of Dolfin and your assets continue to be held by Dolfin as custodian and the position in respect of your assets held by Dolfin remains unchanged from the position outlined in our initial letter of 1 July 2021.

The JSA’s priorities include facilitating an orderly and coordinated return of client monies and client custody assets to you and the other remaining clients in accordance with your and their respective interests in accordance with special administration regime.

This is a complex process and there are a considerable number of issues to be resolved. We fully appreciate that this will cause difficulties for those clients and other stakeholders who are affected during this challenging time.

The JSAs will be seeking to manage the process as expeditiously as possible and to minimise any hardship and inconvenience caused to clients as a result of Dolfin entering special administration. Unfortunately, at this relatively early stage, we are unable to provide details of the likely timing for the return of client monies or custody assets. We will aim to provide further information on progress and timing in future updates, the next of which will be as part of the JSA's proposals on the Special Administration in the coming weeks.


