Investment Objective

The Cautious portfolio aims to deliver a real return, in-line with the risk guidelines below. The portfolio aims to achieve its objectives through investment in a global portfolio of equities, bonds, commercial property and other asset classes. Exposure will be primarily gained through collective investment schemes (unit trusts, OEICs, investment trusts, ETFs).

This portfolio is appropriate for an investor who is comfortable with low volatility of returns, typically having around 40% of their portfolio invested in equities, and who is able to tolerate a loss of up to 12.5% of the value of their portfolio in any one year. This percentage loss is based on what might be reasonably expected 95% of the time. The projected annualised rate of return over the longer term is the Consumer Price Index (CPI) +1.5%.


