

PRIZE DRAW TERMS AND CONDITIONS

1. GENERAL

- 1.1 We are Evelyn Partners Services Limited registered in England and Wales at 45 Gresham Street, London EC2V 7BG, company no. 05169111, authorised and regulated by the Financial Conduct Authority. In these terms and conditions ("T&C") we are referred to as "we", "us", "Promotor" or "our".
- 1.2 These T&C govern the Prize Draw (as defined in clause 3).
- 1.3 Participation in the Prize Draw constitutes acceptance of these T&C. By entering the Prize Draw all entrants will be deemed to be bound by the T&C.

2. ENTRY REQUIREMENTS

- 2.1 The Prize Draw is open to City A.M readers who are UK residents and aged 18 years or over.
